Instructions:

The registration form can be filled in electronically or alternatively you can print out and scan the filled form.

In the column "Quantity", please sign in for the parameter you would like to participate in, e.g. "1" for one set of samples, "2" for two sets of samples. The indication of the "Method" in this application is purely informative and voluntary.

For each sample set ordered, we charge a set fee plus an evaluation fee of 22 € per parameter.

If you return several analyses/methods from the same set, 20 € each will be charged for the additional evaluation. Please note that packaging, delivery costs, possible veterinary costs and customs fees will be charged separately and communicated to you along with the order confirmation. For international bank transactions (outside the European Economic Area) a bank processing fee of 35 € will be charged.

Examples:

- If you would like to participate with the parameters fat, protein and lactose monohydrate please enter in each case "1" under row "number of sets". You will be invoiced 166 € (100 € set fee + 3x22 € for the parameters) and your sample set will contain samples 1-10, each with a volume of 40 mL.
- If the volume of 40 mL per sample is not sufficient for your analyses, e.g. because you would like to determine all three parameters with the reference as well as with the alternative method, enter e.g. "2". In this case, you will receive two sets of samples (80mL) and you will be invoiced 332 € (2x100 € + 2x(3x 22 €)).

You also have the option of ordering sample material from the proficiency test up to 4 weeks after publication of the final report. The costs for a reordered set correspond to the set fee (set 11-16, 17-26 and 27+28 each minus the 22 € evaluation fee).
